- e. It was reported there was unwanted plywood and railroad ties at the community burning pile. These cannot be burned. Gerlich will call a vendor for their removal. Halvorson agreed to make signage to outline what is and what isn't allowed to be dropped off at the burn pile.
- f. Gerlich reported the DOR had revoked the Seller Permit for Rockdale Bar & Grill on June 16, 2021. The establishment was closed down by the DOR on June 17, 2021. The applications for Class "B" Retail License and Cigarette & Tobacco Product Resale License were submitted to the Village of Rockdale on June 17, 2021. No action can be taken until the Rockdale Bar & Grill are in good standing with the DOR.
- g. ARPA Local Fiscal Recovery Funds Allocation has designated \$22,608.41 to the Village of Rockdale. The first installment will be distributed around June 25, 2021, and the second installment will be 12 months later.
- h. Nelles will attend a video hearing with the Madison UI Hearing Office regarding Gary Hartog.
