1. **Call Meeting to Order.** Village Board President Timp called the regular meeting of the Rockdale Village Board to order at 6:08 p.m. in the Robert M. Smithback Community Center.

- 4. **Acknowledgement of Meeting Notice/Posting.** Clerk-Treasurer Dieckhoff confirmed the meeting had been properly posted.
- 5. **President's Welcome/Announcements.** President Timp welcomed all visitors.

A map was presented. Rucks indicated that when the snow gets deep he cannot clean the sidewalk as indicated in green with his snow blower. We need someone to do shoveling in that area. Castle agreed to clean up that area. The area in orange sidewalk has not been cleared of snow. We need to remind the property owners that the snow needs to be cleared.

- That the Village of Rockdale approved the 2018 budget portion of the Cambridge Community Fire Commission for Rockdale in the amount of \$7,728.18 at our current meeting.
- The Village of Rockdale has not budgeted any additional funds in the 2018 budget for the purchase of a fire truck.
- The grant request was made by the Cambridge Community Fire Commission.
- If the Foundation has any further questions specific to Rockdale to feel free to contact us.

e. Discussion and possible approval of 2018 Sewer Utility Budget.

Rucks indicated that the Sewer Commission met prior to the Village Board Meeting. The Commission is looking at a possible rate increase next year (2019) of \$20 per month. There may be a need to borrow money to do sludge pumping at a cost of \$7,000. The Sewer Commission will be meeting in March to obtain quotes on doing the work this year. An updated Sewer Utility Budget will be brought back at the March Village Board Meeting for approval.

f. Discussion and possible approval of purchasing computer software (Malwarebytes).

There was a problem encountered on the Clerk computer recently with a virus.

Motion by Castle, second by Nelles, to purchase Malwarebytes software for Clerk computer only. Motion carried 5-0.

Motion carried 5-0.
